

# Updated CPR Uni-padz<sup>®</sup> Placement Illustrations for Child/Pediatric Use


With software Release 6, ZOLL is updating the illustration used for the placement and location of the CPR Unipadz electrodes on pediatric/child patients.

# **Updated Prompt Flow for Child/Pediatric Use**

Several changes were made to the ZOLL AED 3 device prompts including the addition of four new prompts when in pediatric mode. These new prompts focus on the placement of the CPR Uni-padz on a child/pediatric patient.

The changes include:

- The removal of the initial announcement of "ADULT PATIENT SELECTED" prompt . The ZOLL AED 3 device will now only announce "IF PATIENT IS A CHILD, PRESS CHILD BUTTON"
- The addition of new prompts during the attach electrodes sequence (for pediatric patients only):
  - "ATTACH BLUE PAD TO CHILDS BACK"
  - "TEAR PURPLE SENSOR AWAY FROM GREEN PAD"
  - "PLACE PURPLE SENSOR ON GREEN PAD"
  - o "ATTACH GREEN PAD TO CENTER OF CHILD'S CHEST"

# **Updated Part Numbers for CPR Uni-padz**

With this change ZOLL is releasing an updated version of the CPR Uni-padz electrodes. The new part numbers are listed below. All ZOLL AED 3 devices shipped with Software Release 6 will include the new version of CPR Uni-padz. ZOLL will continue to offer all three versions of CPR Uni-padz, refer to the latest International AED price book for pricing. All CPR Uni-padz III part numbers are below:

Customers with existing CPR Uni-padz Demo/Training pads do not need to purchase new kits, they simply can purchase updated training pad gels that use the updated placement recommendations.

### **Self-test Push to USB**

#### **USB Self Test Push Enabled:**

- The user can now configure their ZOLL AED 3 to automatically export the device self-test file (DSF) to a pre-installed USB drive following the completion of a periodic self-test. This feature allows users to collect the results of ZOLL AED 3 device self-test without using WiFi transmission.
- When this option is set to On, the device sends the self test data file automatically to the pre-installed USB drive. This option is located within the Advanced Configuration Menu, in the Device Configuration section.
- The number of DSF's stored on the USB drive is dependent on the size of the drive, files will not be overwritten.

### **Device System Hardware Requirements**

This software release is compatible with ALL ZOLL AED 3 devices manufactured to date.

#### **Production Release**

ZOLL Operations will phase in the updates as follows:

• ALL applicable ZOLL AED 3 devices shipped from ZOLL Chelmsford after 08 July 2020 will include SW Release 6.

#### **Software Upgrade Process**

There are two options to obtain the Release 6 software upgrade files:

- 1) FREE Electronic Delivery. Email ZOLL Technical Service to request an electronic delivery of the software file (download from secure file server)
- 2) Purchase a Programmed USB Stick. You can purchase a USB stick with the Software Release 6 file preloaded (\$25 USD) from ZOLL Technical Service

**IMPORTANT** Changes to the Software Upgrade Process

 When updating the software on your ZOLL AED 3 device, the USB stick now MUST include individual languages files. If the USB stick does NOT include these files, the image shown below will appear and you will not be able to update the AED's software. Please contact ZOLL Technical Service should this appear, to obtain the associated language files. Adding additional languages or changing the default language files is not possible, only the pre-installed language files will be updated.



- Following the completion of the software update the device will display an "UPGRADE COMPLETE" message.
- Should the software upgrade fail for any reason the following image will be displayed. Please contact ZOLL Technical Service for support.
